



# CCJDA Child Care Grant Program

## Program Information

### Existing Child Care Providers

- \$750/year to existing licensed child care providers in Cavalier County each year they renew their license and have 1 year of no critical violations
- Grant funds must be used for expenses related to Child Care, receipts must be provided.
- Are also eligible for Employee Training Grant

### New Child Care Slots\*

- For New or Existing Child Care Providers in Cavalier County that add new permanent year round licensed child care spots
- Grant of up to \$500 per new slot created
- Maximum benefit for program will be \$5,000 per year for home based Child Care, \$10,000 per year for Child Care Center
- Must be licensed, however, a one year grace period will be considered for new child care providers so the provider has the necessary timeframe to be licensed.
- Program total of \$25,000—first come, first serve
- Must remain open for at least three years or child care provider will be required to repay the grant prorated based on time in business
- Grant money must be used towards expenses directly related to Child Care ( i.e. licensing, equipment, cribs, changing tables, home updates related to child care such as fence, egress windows )
- Must provide receipts/estimates totaling grant amount

*\* A slot is a spot licensed for one child. Currently there are 119 licensed slots in the County the goal of the program is to increase that number. Slots should be permanent and year round in order to be considered for this grant program.*
